- Sue Belval / Pastor Andy Plans for Welcoming Introducing Rev. Beaton's 8/3-4 (his first service)
 - Same copied packet included "An Order for the Celebration of an Appointment"
 - A welcome banner will be hanging with balloons, white tablecloths, centerpieces
 of bowls and balloons; will need help with balloon setup at 9am on Saturday
 - Extra donuts have been ordered
 - Need 5 Board members to cover parts in the service
 - Sue to present the stole at each service
 - Mindy Saturday and Sunday
 - John H Saturday and Sunday
 - Dave 9 and 11

- Sue Belval Recap of the Missouri Annual Conference Meeting
 - o It was Sue's first time attending and felt proud "to be a Methodist" upon leaving
 - o Conference by numbers -
 - 31 churches closed in MO this past year
 - \$15,000 raised for Mozambique Initiative
 - \$14,000 raised for Puerto Rico
 - Many ordained over the weekend
 - Honored and remembered those lost over the last year
 - Trish Gumby was certified as a Culture Coach
 - Andy Blacksher played keyboard during a worship service
 - Rev. Ron led a service
 - Lots of talk of unity, knows there still may be some hurt going on, but disaffiliation is over
 - New district superintendent for our area Adrienne Denson Ewell; former DS Robyn Bell will serve KC area
- Joy Parisien Sneakers with Soul Volunteer Opportunity
 - Asking for Board members to volunteer on Friday 8/9, 9-12 at Guardian Angel Settlement on South Jefferson
 - 5 staff members are signed up
 - Sue, John H, Jim and Sue, Pastor Ron
- Pastor Andy Financial Report - Current Position, Anticipation for Remainder of the Year
 - \$261,000 off from where we should be, about one month behind (average month expenses = \$251,000)
 - Similar slump from last year
 - A fairly recent tax law change affected giving somewhat
 - Andy has spoken with a former "large giver" about this year
 - Pastor Ron will reach out to others upon his start
 - Sitting on some money to help with AC, but not moving on that until something crashes
 - Mortgage principal down to \$217,000
 - Days of expenses 99.65 (goal 90 days average)
 - Money from house sale went into Feb's report (earmarked for capital expenses)
 - June projected budget \$181,000, actual \$119,000

- John H discussed with Andy a campaign of giving this fall; Andy questioned sending a new pastor in to ask for money in his first months here.
- Craig questioned where else we can pull money from . Pastor Andy cited the Edward Jones, Sterling bank, and Investment accounts which together total approximately \$1, 494,000 as available for use if necessary
- Sue reminded us that the giving spikes in the last few months
- o Sara hopefully with the new, fresh start (unity) will inspire giving
- Andy would like to let Ron be new and generate enthusiasm, THEN let staff put together a campaign based on his vision based on what he hears from congregation, focus on 2025 and year 200. "Generosity begets generosity."
- Operating cash is first place to look for money, then move money from Sterling Bank operating (money market account), then not renew a CD from Edward Jones (NONE of this has been done as to date)
- Doug asked about plans for attendance growth
 - Ron will be in learning mode for about 2 mos
 - Phase 2 report back to set new vision and direction
 - Phase 3 new campaign and outreach, marketing, finance
- Summary no emphasis on giving at this time, "hanging on," reevaluate around October

John Heskett – Discussion Regarding a Congregant's Letter

- Concerns shared around transparency, same-sex marriage decisions, lack of calling for congregational vote
- John H has drafted a response, asked for feedback
- Joe suggested that our congregation be more informed of Board decisions
- Craig reminder that Board meetings are open
- Andy the Book of Discipline does not support congregational votes, this is the purpose
 of the Leadership Board
- Andy wished we met in a more welcoming space to allow for more visitors
- Andy value in having a "Here's what we are hearing" meeting to share about budget, etc. A "Town Hall" of sorts
- Will have a Year-end Report this year
- Dave suggested a one-on-one meeting with himself, John, Andy, Sue
 - John agreed that this was a great way to go about a response

Pastor Andy – Proposed Policy for Tuition Reimbursement Benefit

- Total budget impact 2024 \$2065, 2025 \$7875
- \$5250 per person per year
- Has to be approved by HR
- Has to be related to your job here at MUMC
- Will be paid up front, then reimbursed
- Must be a degreed program
- Passing grades only (C or higher)
- No reimbursement if terminate their employment or terminated

- Sara suggested a commitment to the church for a period of time after education
 - Andy hard to enforce
 - Craig deduct from their last paycheck
 - Mindy suggested one year
 - Joe questioned Circle of Friends, but this does not cover them as it is a separate entity
 - Andy staff has shared that they do not know how to access Continuing Ed, and he is prioritizing that for staff
- John M motion to approve policy, Sara second policy to require one year continued service at MUMC when reimbursement is received. Unanimously Approved

Pastor Andy – Plans for Rev. Nienaber's Consultation with Staff and Board Members - 8/25

- Reimbursement from the conference of \$5000
- Board meeting immediately after church, about 3-4 hours, 12:30
- Tiffany ordering Jimmy John's
- Staff meeting on 8/26, zooming with staff ahead of time per staff interest
- Including former board members who rotated off/resigned over the last year

Pastor Andy – Planning for Fall Kickoff (formerly Homecoming) on 9/8 - Board Involvement and Support
